Job Description: MUKSW Innovation Manager

The role of the MUKSW Innovation Manager is to successfully deliver the "GSW Marine & Maritime Launchpad Cluster Innovation Program" between September 2024 and June 2026". The project ambition is to create a sustainable cluster model such that at project end the MUKSW Innovation post should have created sufficient revenues to be self-financing and sustainable. This will be partially the responsibility of the post holder to create sufficient value to drive new cluster members and drive revenues through on profile contract and or bid delivery to sustain the post.

The GSW Marine & Maritime Launchpad Cluster Innovation Program (CIP) will be delivered by Maritime UK SW (MUKSW), a globally significant maritime innovation cluster established in 2015, covering Cornwall, Devon, Dorset and Somerset comprising a partnership between business, place, and research.

Funding from Innovate UK of £150,000 will act as a multiplier for existing Maritime UK SW innovation delivery in the Great South West by enabling a full time Cluster Innovation Manager to be employed to develop a broad program of innovation, investment, support and promotion, supported by the existing MUKSW Chief Executive and the network of MUKSW innovation partners - drawing in world class expertise.

The Cluster will be developed alongside existing added value MUKSW activity including: skills, careers, clean maritime, economic analysis and lobbying and will be delivered in accordance with the "Hubs of Innovation: A playbook for Place Leaders model" proposed by IUK.

MUKSW will deliver project objectives by building on existing strengths, developing networked regional hubs as foci for project activity working with partners to extend existing geographic and thematic strengths, hosting and signposting on-profile innovation, investment and support offerings, also building on existing promotional and investment assets thus further embedding the inclusive innovation mission/culture MUKSW has developed across the GSW region.

Role outputs

• Conducting an audit of industry need and enhancing existing sector knowledge

- Developing web and print collateral utilising MUKSW existing national and international profile to champion and promote the culture and reputation of cluster innovation.
- Running a programme of at least 12 innovation sandpits
- Hosting 12 online drop-in problem-solving/innovation transfer sessions
- Organising an "Ocean Tech Expo",
- Establishing a mentor network
- Offering 1:1 business support
- Convening national, MUKSW and GSW partnerships to focus on strategic investment in: decarbonisation, AI and autonomy, digitisation of ports and shipping and enabling floating offshore wind supply chain
- The CIP business plan is designed to offer value for business alongside the sustainable, partner owned and led business model of MUKSW such that at project close levels of support will be maintained, creating a highly valued innovation cluster

Project outcome measures:

Ensuring that 15 mentors are in place

Supporting at least 10 consortia and bids

Generating £5M in public Innovation bids

Generating £5M Innovation investment through private contributors

Ensure that GSW maritime level and intensity of innovation, investment and promotion activity and engagement are increased across the region, with established hubs in North Devon, South Devon, Cornwall and Dorset

Attracting national and international actors into the cluster including via the MUKSW investor network

Demonstrating increased sovereign capability leading to import substitution

By project end, being able to demonstrate that £70,000 additional revenue has been generated by MUKSW to maintain level of cluster support post project.

Person Specification

Required experience and knowledge

Deep knowledge of the UK and South West innovation, finance, and skills support ecosystem in order to signpost and advise businesses appropriately. It is critical that the successful candidate holds current knowledge and contacts to be able to ensure delivery of the aims and outcomes set out above.

Deep knowledge and contacts within the South West maritime business and periphery sectors with a focus on R&D active businesses across the South West and beyond. The successful candidate should be able to demonstrate similar knowledge and ideally contacts within the research community and public sector.

Demonstrable experience of achieving outcomes from business engagement leading to innovation, business growth, investment and collaboration.

Deep knowledge of grant funding. Knowledge of the bid process via Innovate UK and other funders of Innovation in order to pragmatically advise business.

Evidence of successful previous public sector sourcing and writing successful funding applications for innovation, either individually or as part of a team.

Evidence of successful bid management, working with Innovate UK or similar organisations funding innovation including European funding and Research Councils or similar. This to include demonstrable experience of the process of managing publicly funded projects over the value of £4 million.

Sound knowledge of modern IT systems and ability to adapt to and implement IT systems which create efficiencies.

Experience of setting up and growing networks of business, working with businesses face to face and on a one basis.

Project, public procurement and contract management experience. Ideally with projects of over £3M.

Demonstrable experience of marketing to business: knowledge and ability to manage a website, newsletter and manage the production of print and web collateral via contract and build social media presence.

Experience of arranging successful business events within the parameters of a set budget.

Innovative, commercially focussed thinker: ability to self-start, gain support and self-finance projects across numerous partners. Ability to adapt to a range of tasks in a small and ambitious organisation.

Willing and able to travel in the South West with some UK travel and occasional, infrequent international travel.

Desirable experience and knowledge

Knowledge of UK government policy regarding maritime regulation and growth. Experience of working within a public sector environment, including working alongside public officials and political representatives.

Ability to communicate effectively across various levels in organisations of varying sizes.

Knowledge of subsidy control and legislative control around the management of public finances and projects.

Experience of working with other national and international marine sector groups and governing bodies.
